

About our speaker Caroline Ingram

Caroline Ingram is a research assistant at the University of Western Australia. Her research interests include Western Australian history,



Australian legal history, women's history and the history of marginalised people. She currently works for the Australian Legacies of Slavery project and the Two Centuries of Chinese Heritage in Western Australia project. She received her PhD in 2024 for the thesis 'Women in the Court: An Examination of Women's Trials Heard in the Court of Quarter Sessions and the Supreme Court of Western Australia, 1830–1890.'

Topic

Criminal records can tell us a lot about how women in the colony of Western Australia were treated by the criminal justice system – but, when read 'against the grain' they are equally as good at shedding light on the everyday lives of working-class women. By combining information from the criminal indictment records, newspaper articles and various diaries and journals from the State Library collection, we can also get an idea of the pathways that led women to offending and the impact that the trials had on their lives. Caroline's talk will discuss how different legal rules and institutions affected the trials of colonial women, how the trials were gendered and what the trial records can tell us about the lives of these women.

Ruth Marchant James OAM (1929-2025)

Goodbye to a Gem

Ruth Marchant James, who died on 6 August, aged 95, was a Gem of Time, thanks to the Friends of Battye Library who added this formal accolade to

others that had come her way in a life of authorial achievement.

Gems sparkle, don't they? This one certainly did. In 2006 Ruth shined brightly enough to go on the Friends list for outstanding contributions to the recording, collection and preservation of WA history.

On the domestic front, at the home in Karrinyup she shared with husband Bill James, Ruth was most smiley of hostesses, catering for guests enjoying food and drink while going backwards and forwards between the kitchen and the outside area next the swimming pool. She bustled without hustling.

As a writer she knew how to get the best

out of people, whether her intellectual arena was Cottesloe or the legacy offered by the nuns who had taught her at Iona Presentation College in Mosman Park. Judging by her later years, we can surely assume that the young Ruth was rarely reticent in putting her point of view. The author of several exceptionally researched and crafted works of WA history, Ruth recieved the 2007 Premier's Book award for *Cottesloe: A Town of Distinction*. Her 2006 Gem of Time citation, recently republished in this *Newsletter* featured her many and impressive achievements.

Five brothers, no sisters. She must have had plenty of practice at assertion around the dinner table. Ruth had a sort of busy grace. Bill's death four years ago was a severe blow but unlikely to still her voice.

At her funeral in August I made sure to talk to all three of their children, Rochelle, Damien and Kieron. They were proud of the mother, historian, guide, entertainer and Gem.

Peter du Cane (1951-2025)

Peter du Cane, who died on 28 March, aged seventy-four, was a writer, producer, and director. He was also a renowned filmmaker who was responsible for award-winning wildlife and historical films and documentaries.

Peter also had a mission to save film in archival repositories, hence his interest in the Battye Library and in the Friends. He had been a member since 2018 and wrote an

article for our November issue of that year which highlighted the looming problem facing collecting institutions like the State Library and the State Records Office.

Bill Bunbury, who interviewed Peter in November 2017 for the National Film and Sound Archive Australia, remembers Peter as an impressive, sympathetic, and productive film-maker, adding that he felt privileged to have been able to record the career such a skilled documentary producer.

Professor Reginald Thomas Appleyard (1927-2025)

Born in Claremont, Reg attended Swanbourne State School and Fremantle Boys' School. He served in the Merchant Navy 1946-47, travelling much of the world as a deck hand. In 1954 he completed an Arts degree, specialising in Economics, graduating with first class Honours. Funds provided by the Rockefeller Foundation allowed Reg to attend Duke University where he obtained a PhD in 1956.

On returning to Australia, Reg took a position in the Department of Demography at ANU, which from 1957-1968 was working for the government, researching why many £10 immigrants subsequently returned to the UK. Reg then turned to a longitudinal study of Greek migrants which resulted in two books. In 1966 he was offered the new



Chair of Economic History at UWA. Reg later became head of department, remaining in that position for seventeen years. A gentle man who disliked conflict, he worked hard to maintain harmony and staff appreciated his consultative approach. Fortunately Reg had retired before Economic History was virtually abolished and economics relegated to just enough units to comprise a major. It was recently noted that Reg was Acting Director of the GSM 1992-1993 working there in his retirement in 1992, thereby influencing many people across the Business School.

Reg believed economists should be skilled in three areas - Economic theory, Economic

History and Measurement (Economic Statistics) - with Mathematical Economics increasing in importance over the years. He was a pivotal figure in running the Economics Department at UWA. He held the Japan Foundation's 1973 Distinguished Visiting Fellowship and received the Austin Holmes Award in 1992. Perhaps his most important contribution to the University was his role in introducing the Japanese Studies programme, which combined the Japanese language and studies of its culture with an economics degree.

His publications included *Immigration: Policy and Progress* (1970), *Ten Pound Immigrants* (1988), *International Migration Today* (1988), and *The Beginning: European Discovery and Early Settlement of Swan River, Western Australia* (1979).

Amember of the Friends from the 1980s to his death, Reg had an amazing collection of Westraliana which comforted him in retirement. Reg and his late wife, Iris, lived in City Beach. Our condolences to daughters, Helen, Ingrid, and Wendy, and granddaughter Bianca.




Have you a story to tell?

[Senior Archivist, David Whiteford, who will be well-known to our members has written several fascinating articles for the Newsletter most of them on the origins of places and their names.]

An A - Z of WA - Zamia

In my previous article I covered WA's only 'X' locality, Xantippe. The letter Z is represented in WA by a number of topographical, locality and road names but on the railways of WA there were only two sites with the first letter Z. The Commonwealth Railways had Zanthus on the



Trans-Australian Railway and its office shed is preserved in the rail transport museum at Bassendean. The only WA Government Railways locality was Zamia, a passenger landing on the Mundaring branch between Mahogany Creek and Mundaring and 20m 11ch from Perth. Although the WAGR operated

the zig-zag on the Upper Darling Range Railway (now a well-known tourist drive down the Darling Scarp from Gooseberry Hill), there was never a locality actually named Zig-Zag (unlike in NSW).

The Mundaring branch (earlier known as the Smith's Mill branch) was part of the original Eastern Railway with the section from Guildford to Chidlows Well opened on 11 March 1884. As the rail system expanded east and trains and freight grew, the original route proved insufficient and was relegated to a branch by the opening of the new Bellevue – Mount Helena route via Parkerville on 1 July 1896. But even as a branch line, the section remained busy with local and some through trains.

In December 1912 an additional stop was provided with the construction of a rail level landing at mileage 20m 11ch (Telephone post 401 to be precise). The landing was completed on 5 December.

Despite the WAGR annual reports being very thorough in reporting even small works, there is no mention of the construction of the new landing in the 1912-13 report. Weekly Notice 4, 1913 p.115 announced the naming of the stop as Zamia and confirmed that as well as passengers it was available for goods and parcels up to 10cwt, easily handled by the train guard. However, the landing was without a shelter until a shed was erected on 14 October 1914.

Weekly Notice 29 of 1927 confirmed that Zamia was handling some goods, as a ledger account was opened with the Glen Forrest (formerly the aforementioned Smith's Mill) station master for goods consigned to Zamia to E M Anderson. I've been unable to locate any Anderson listed in Mundaring, Mahogany Creek or Glen Forrest in the annual *Post office Directory* for 1927-1931. Zamia is listed in the towns directory but only as *See Mundaring*.

Zamia continued to serve the local community until the closure of the railway from 23 January 1954, although most passenger services had been provided by bus for some years (Weekly notice 4, 1954 p.83)

The shelter shed was removed by the Glen Forrest P&C Association in November 1962 and the station nameboard was kept by the Mundaring Historical Society. The site




Mundaring Historical Society (Jeff Austin)

of Zamia is on the Kep Track / Railway Heritage Trail that utilises most of the former Mundaring branch formation but the site of the stopping place (adjacent to the Coppin Road level crossing) is not recognised by any signage.

However, there is currently a Zamia railway station in Western Australia – on the Bennett Brook Railway in Whiteman Park. On the bush loop line, the station was provided to serve the then Keith Maine Youth Camp and was called Maine. But camp changes and a little confusion with not being a 'main' station (the railway also had Central Station, changed to Whiteman Village Junction in January 1992), saw the name changed to Zamia early in 2008. This was a nod to both the original Zamia stopping place, and to the zamia plants found in the park.

As at 7 October 2025 there are seventeen entries in the State Records Office online catalogue for a Zamia search. Most of these deal with the zamia palm but there is one for plans of the railway site, a couple for court

cases involving someone living there, a couple relating to a government water tank at Zamia, a Forests Department file on Zamia Block, and road matters for Zamia Street, Mount Claremont. The State Library catalogue has 23 entries, again many are for the zamia palm but there are some photographs taken in the area, a series of buildings along Zamia Street in Northcliffe, a couple of motion picture entries with an actor named Zamia Fandio. There is even some drone shot film footage of a train on the Bennett Brook Railway approaching its own Zamia station in 2022 and 2017 'dash-cam' footage from a locomotive cab as a train runs along the line. The National Archives of Australia catalogue has twenty results for a zamia search. Of course, the palm features strongly, and there are some Queensland references for a Zamia Hill, and one for a sailing vessel named *Zamia*. But there are a couple of WA land sale files for properties at our own Zamia.



The earliest surviving survey plan of Perth, 1829

Late in 2024 I discovered within the SROWA collections what appears to be the earliest survey plan of Perth. The plan shines a light into what may have been the original attempt by Lieut. Governor Stirling and Surveyor-General Roe to impose a European town layout on their chosen site of Perth. It also records features of the Perth foreshore at the very start of Swan River colonisation.

The plan survives because it was re-used to make a cover for a register of Survey Office correspondence.¹ It is relatively intact, other than a small hole in the top-left corner and some bleed-through of lettering from the register's title page. Due to the way the register pages (folded foolscap) are stitched into the cover it is only possible to view the map in two halves. It has been scanned and digitally reassembled, though further work is required to produce a more exact digital copy.


Its extent is from present-day Barrack Street to Bennett Street (north-west to south-east), and Murray Street to river bank (north-east to south-

west). Sections of land are set out in with designations A, B, C, D, E, and K, all of which were perpetuated in later plans except for K. Sections A, C, D, and E (boundaries only; not coloured) are subdivided into allotments. Colouring sections indicate reservation: A, B in red (government land), K in green (tilling or agriculture).

The plan has some interesting features:



• Earliest detailed depiction of the central Perth topography, by means of black/grey watercolour and ink shaded relief. The foreshore is also 'hatched' in vertical line clumps that may suggest vegetation such as rushes or low shrubs and adjoining the water's edge some shading may indicate marshy ground. In the top-left corner the same technique indicates the south-east tail of (not-yet-renamed) Lake Kingsford. Topography above the river is also depicted, except where allotments are laid out.


- Four drainage lines are indicated, the largest two in the vicinity of present-day Government House running from St. George's Terrace to the foreshore. The largest of these was later covered by a small bridge before being filled in.
- The square section marked 'K' is hatched in green lines at right angles to suggest intended tilling, which aligns with its reservation as the Barracks Garden.²
- St. George's Terrace the only street named on the plan runs straight in a consistent width across the plan. There is no riverside protrusion of most allotments in sections C, D, and E.
- An origin point for the survey is indicated on the Terrace below allotment D6, with chain divisions on the Terrace line to the west and east.
- Below present-day Pier Street is a faintly-drawn jetty, one of the earliest colonial structures in Perth.
- There is a mysterious crossed-out word along the left-hand margin near section K; it appears to read "Eyes of [?]". Annotations elsewhere include D, 88, 300+
- An empty tabular grid in the lower quarter of the plan [which has been cropped from the plan for better reproduction in this Newsletter] may have been intended to record the first occupiers of each allotment.
- Four bearing lines drawn in ink bisect the plan, but their origin points sit beyond the plan boundaries, making it difficult to know their purpose. This suggests the plan was cropped from a larger sheet (e.g. section E continues beyond the right-hand edge), but no other fragments were located during a brief search of early Survey Office register covers.

Some expected features may be 'missing' because they were surveyed after this plan was made:

 Howick Street, later Hay Street, is not shown, hence section allotments run two deep from the Terrace. Those living in the back allotments would have had a longer 'commute' to the river, the major means of accessing Perth at its commencement. This may have led to Howick being surveyed in late 1829.


- Section B (for Barracks), is a single large area that is eventually bisected by Howick/Hay Street.
- There is no large church site reserved for the Anglicans it was not added to the middle of sections A and C until mid-1830.

This plan appears to represent Roe's initial survey and layout in August 1829, and was intended to facilitate the taking up of allotments the following month. Cross-reference to Survey Office diaries (SROWA series1861 cons5000) tentatively support this conclusion, though the September–October diary is missing. Part of the rediscovered plan has similar information to field notes in an early Survey Office field book³ which shows a sketch layout of sections A, C, D, and E, and refers to the survey base line as the 'Terrace line'. This field book page is probably of a later date as it includes features not on the plan, such as an 8 October 1829 assignment to 'Mrs Daly'⁴ and a wetland beyond section D and E.

Previously, the earliest known survey plan of Perth was by Arrowsmith, published in London in May 1833⁵ from documents in the Colonial Office, London. Arrowsmith's plan depicts a larger area, showing many more parcels and streets; some allotments in sections A and C have been altered to create Howick/Hay street and a reserve for a 'Church site'.

The foreshore edge in both plans is similar. Arrowsmith's plan is derived from an earlier one completed by George Smythe in August 1831, and sent to London with Lieut. Governor Stirling. Smythe's plan also survives (not at SROWA), but that is for another time.

The Night the Hangman Came to Bunbury

After the Second World War, boarding houses in Bunbury provided many people with alternative accommodation. The port town boasted a range of lodgings for tourists, travellers, single men and women, everyday working class people, and boarders of all ilk. Everyone had a story and boarding houses were known for their characters, although mostly, apart from advertising, the houses received more attention for mundane matters. In 1951 in the *South Western Times* the editor lectured about parked cars that:

...must be somewhere, of course. People who work in the town and get to that work by car, must leave their vehicles somewhere — but it does NOT necessarily have to be right outside the door of their hotel or boarding house.¹

However, sometimes there was more excitement, like the night the hangman stayed in town.

In 1952 the arrival of a mystery visitor would be whispered about as the night the hangman came to Bunbury. There was only one hanging in Perth in the 1950s, that of Karol Tapci on 23 June

"Bunbury Is Already Booked-Out"

Sir,—I, with others, take exception to the remarks of G. Clarke, the manager of the S.W. Tourist Bureau, as published in your last week's issue of the "South Western Times." Several guest houses and at least one hotel have not yet been approached as to accommodation available for the period mentioned.

1952, who was hanged for the murder of Norman Perfect at Wubin, on 17 March. The newspaper report told how:

The execution was the first in Fremantle Gaol since 1932. It was watched by the Comptroller-General of Prisons (Mr A McKillop), the superintendent of the prison, the prison doctor, two priests and a number of duty warders. After the hanging Mr. McKillop returned to his office in Perth where he issued the following statement: 'The execution of Karol Tapci was effectively carried out at Fremantle prison this morning at 8 o'clock in the presence of the usual panel of gaol officials. The proceedings were decorous and without untoward incident. The Rev. Father W Cowan assisted by the Rev Father Joseph Peksa, attended

Tapci, whose last words, in reply to the usual inquiry, were: "Goodbye, Thanks for everything. I am very sorry I killed a citizen of your country." The identity of the hangman, who is believed to have come from the Eastern States, is known to only two or three prison officials.²

In Bunbury it was rumoured that a certain stranger, who had checked in to one of the town's boarding houses, was in fact the Eastern States hangman. Why the hangman would be in Bunbury is not explained. Perhaps he came by coastal ship from Melbourne or Sydney, to the port of Albany - an anonymous trip? Then by train from Albany to Bunbury, stopping over prior to travelling to Fremantle, to execute his grisly task. Whatever the case, overnighter or not, the suggestion that the grim executioner should be in Bunbury was enough to get tongues wagging. Somebody always knew someone, who had heard from somebody else, of the comings and goings of boarders. If they were outsiders, all the better ground for speculation and hearsay. Neighbourhood chatter about the social happenings in Bunbury, true or not, was always a rich source of gossip. A hangman on a mission was quite the story, maybe good business for the keeper of the house, maybe not.

New Acquisitions

Henry Charles Prinsep and Prinsep Family Archive

The Prinsep family are significant for their role in the history of Western Australian settlement but also for their international presence, with widely cultivated familial, social and mercantile networks that extended throughout the British Empire. These connections are well documented in this collection of material, comprising of over 3,000 items, including manuscript material, chiefly correspondence, as well as photographs, artworks, ephemera, and published materials.

Captain John Thomas papers

This collection provides a unique insight into the shipping and maritime trade of colonial Western Australia, which was vital to the establishment and development of the fledgling colony. It includes the bills of lading and shipping inventory, detailing what trade goods were in need and what Western Australia was exporting at the time.

Nuova Norcia. Missone Benedettina Nell Australia Occidentale (Monochrome lithograph, Guglielmo Ewing lithographer, circa 1864.)

This lithograph is an important acknowledgment of Indigenous communities in the settlement of New Norcia. It depicts two forms of Indigenous life after settlement: a village of houses for Indigenous persons and families, and a group of Noongar people living in pre-European style.

Set of photographs of Fremantle Port

A collection of fourteen images showing the construction of Fremantle Port - dredging vessels, construction of timber wharves, workmen and diving equipment.

Bill Angove Private Archive

Bill Angove was a prominent figure in WA's photographic and cultural history. This collection reflects his artistic and commercial success in

London and Sydney in the 1950s and 60s, and includes photographs, letters, business papers, contact books, certificates, small folios of work, an oral history recorded on his deathbed and handwritten notes of recollections late in life.

The winner will be announced at an Awards ceremony in late October.

This annual award honours Miss Margaret Medcalf OAM, Western Australia's second State Archivist, for her landmark contribution to the development of the State archives collection in Western Australia, which was established in 1945 and is 80 years old this year.

Governor's Establishment Records

In June, the SRO accepted an 'emergency transfer' of State archives from Government House. These records date back to the early 1900s and span through to the early 2000s. They include large sets of correspondence files, Governor's Despatches, photographs, government films of royal tours and events, inventories of historical artefacts and furniture at Government House and records documenting investitures and honours awarded.

These records are an important supplement to existing sets of records that the SRO received from Government House in previous decades.

We have noted many interesting finds in within the records this new transfer. as confidential such communications sent to the WA Governor prior to the abdication of King Edward VIII in 1936. correspondence in the early 1970s documenting tensions between Government the and Commonwealth Whitlam Government and even a photograph of Prince Charles windsurfing in WA in 1979.

Most of the records have been processed and will be publicly accessible soon.

Governor Chris Dawson also made a visit to the SRO in June to view State archives related to an upcoming speech he is making. The Governor then had the chance to explore his own family history. He was shown Captain John Molloy's letterbook (Resident Magistrate of the Augusta and Vasse regions in the 1830s) which includes a number of entries relating to the Governor's great-great-grandfather Elijah Dawson, such as Elijah being made Police Constable for the area.

1994 State Cabinet Records

A guide to the 1994 State Cabinet Records was published on 26 September to coincide with the International Day for Universal Access to Information. The 1994 State Cabinet records have been released from their 30 year access embargo and are now open access archives. The records document the initial period of the Richard Court / Hendy Cowan Coalition government. The condition of the Swan and Canning Rivers, deregulation of trading hours, reform of land tax in WA, juvenile justice, and the role of the Collie coal fields in Western Australia's energy equation were some of the significant issues discussed by State Cabinet in 1994.

Structural Changes

As part of broader machinery of government changes, on 1 July 2025, the SRO's parent department became the Department of Creative Industries, Tourism and Sport (previously the Department of Local Government, Sport and Cultural Industries).

The Aboriginal History WA (AHWA) unit is now also reporting directly to the State Archivist. The work of AHWA – which is the lead State agency for Aboriginal family history and truth-telling projects – relies extensively on historical Native Welfare records that are part of the State Archives Collection. This change in reporting will better support the operations of AHWA in the work that they do.

New to the Catalogue

Recent additions to the SRO's online catalogue include:

 Itemised listings / descriptions of regional and metropolitan Police Station records (nearing completion);

- Digital copies of WAGR Roll of Honour Boards of those who served in WWI from the different branches of the WAGR (Cons 7808);
- Digital copies of photos of WA Premiers from John Forrest through to Richard Court (Cons 7812 and 7835);
- Digital copies of LISWA artwork associated with the opening of the Alexander Library Building (Cons 7798);
- Digital copies of Colonial Secretary files (post 1883, Cons 527 and 752) and Police Department files (post 1883, Cons 430).

Digitisation of Colonial Secretary's Office records

Work on the digitisation of the Colonial Secretary's Office records held in the State Archives Collection is progressing well, with the first 160 volumes digitised at time of writing. This project is being funded through the Friends of Battye Library's Sholl Bequest.

Research Sector Support

The SRO has been proving in-kind support to the UWA project team focussed on 'Two Centuries of Chinese Heritage in Western Australia, 1830s-2020s'. This important project aims to collect, record and tell stories of two centuries of Chinese communities' contributions to our State and Commonwealth. The SRO has assisted with the digitisation of State archives that record the entry into WA of Chinese nationals in the late 1800s / early 1900s. Copies of these records are available through UWA's Chinese Heritage Portal and will be used in an upcoming exhibition being developed by the UWA project team.

The SRO has assisted Professor Lee Ann Banaszak, Professor of Political Science and Women's, Gender and Sexuality Studies at Pennsylvania State University during a recent visit to WA. Lee Ann spent two weeks in the archives reading room accessing State archives related to women's suffrage in WA, and the rights of Aboriginal people to vote in elections.

The SRO was also visited by Fiona Giles who has used State archives over the last four years for her Masters' Thesis at Notre Dame University. Fiona demonstrated the board game she has developed as a component of her thesis, which uses real activities, events and people who were at Fremantle Asylum as part of the playing of the game. This is a very novel use of historical and archival sources.

If you've not already done so, we also recommend checking 'Brendan's Odyssey' on YouTube, which explores lost heritage of Perth and WA using historical sources such as State archives. We often see SRO's RetroMaps website (a Friends of Battye Library supported project) popping up in his videos.

Promotion and Outreach

- SRO continues its monthly session on 6PR's 'Remember When' radio series with Harvey Deegan.
- SRO staff appeared on two episodes of the latest series of 'Who Do You Think You Are?' screening on SBS, with Australian actors Mark Coles Smith and Matt Nable.
- The State Records Commission held their June meeting in Albany. Members of the Commission met with State and local government staff from the Great Southern region as part of this visit. SRO staff also partnered with Janet Osborne from Wagyl Kaip Southern

- Noongar Aboriginal Corporation to provide a joint presentation to the Albany community on State archives.
- The SRO has been supporting local company Theatre 180 in recent months. Copies of State archives associated with the 1925 murder at Government House Ballroom were used in the visual backdrop to their new play 'Arthur Haynes and the Smoking Gun' which had its September opening night in Government House Ballroom. The SRO is also supporting Theatre 180 in a similar way for their new play 'Catalpa: Flight to Freedom' which opens at the WA Maritime Museum in late October.

Afterwords - Steve Errington Mrs Mary Charlotte Peel asks for help

The late Friends member Ian Berryman had long planned a new book on Thomas Peel. With his next major work *Swan River Letters volume two* in his owns words '99 per cent finished' he was ready to make a start. He undertook to deliver a paper to the July monthly meeting of the Royal WA Historical Society with the title 'The Private Life of Thomas Peel and Mary Ayrton'. But, as we know, Ian passed away unexpectedly in February.

Peel's wife Mary Charlotte (née Ayrton) and their three children did not come out on the *Gilmore* with him and his reputed child, Frederick Peel,' in 1829. Mary being again pregnant was probably sufficient explanation. The child, Robert, was born in March 1830 and baptised at St Marylebone's Church, Westminster, but seems not to have survived.

Mary and her three children arrived on the *Quebec Trader* in April 1834 accompanied by Mrs Bridget Ayrton, her mother. But Mary and her daughters Julia and Dora left again for London in January 1840. As she later wrote, she did this 'to fit my daughters to become Governesses, should our evil fortunes render it necessary'. Peel promised 'small though punctual' remittances. Thomas junior (and Mrs Ayrton) remained behind.

By September 1842 Mary's plight was desperate. In fifteen months she had received no remittances from Thomas whatsoever. She and her daughters were boarding with two sisters who were running a school in King's Road Chelsea. She was nearly £60 behind with her payments and the ladies were in urgent need of the money.

What she did next, we know from lan's unbelievably patient research. lan's wife Gerry and daughter Caitlin gave me his working file on the Peel paper. What it contained was not the hoped for full draft of a paper, just a page and a bit of lan's handwritten general introduction. But the file also contained something amazing, symbolic of lan's meticulous, painstaking work.


On 21 September 1842 Mary wrote to the most prominent member of Thomas's family, his first cousin once removed, Sir Robert Peel, Prime Minister of the United Kingdom. Decades ago, when the British Library was still part of the British Museum, Ian sat down in the famous Round Reading Room with Robert Peel's official and private correspondence.

In volume CCCXXXV, general correspondence 1-23 September 1842, p. 284 Ian found Mary's letter - it is MSS 40,515 should you go looking for it.

These days you would pull out your smartphone and photograph it. Not then. Ian copied the whole letter and Robert Peel's reply in his neat handwriting using an obligatory pencil. Mary wrote asking for a loan but her words clarify much about her marriage;

From my own family I have been alienated for years for though Mr Peel chose to marry in opposition to his family he did not choose to avow that marriage and my relatives would not I well know receive me in my doubtful character.

In his reply the prime minister wrote that he was 'an absolute stranger to all the circumstances' to which Mary referred but, accepting 'the fact that you are the wife of Mr Peel', suggested that Thomas Peel senior had 'command of pecuniary means' to 'accede to any just application'.

(*Illustrated London News*, 4 February 1843 public domain image) We don't know what happened next, but Mary somehow survived the crisis only to die of tuberculosis in 1857, eight months after daughter Julia died at 33 of the same disease. Daughter Dora returned to Swan River soon afterwards.

But was Robert Peel's unawareness of a marriage significant? Thomas Peel's biographer, Alexandra Hasluck, could find no evidence of a marriage, nor could lan's *ancestry.com* search last December.

What Ian *did* find last December looks like confirmation of Mary's 'doubtful character'. When Frederic Proctor (born December 1817) was baptised In St Marylebone's Church in June 1821, the parents were recorded as Mary Charlotte Ayrton and George Proctor.

What other stories did Ian have for us? Had he noticed that the *Bicentennial Dictionary* entry for Fred Peel included the observation: 'Assumed the surname of Proctor briefly.' Was Fred Peel Mary's illegitimate son, not Thomas's?

We missed out on hearing a very entertaining lecture.
