In his will and the will of his older brother Webster Sylvester – he is only referred to as William the younger also land title documents – copies attached. William the younger's oldest son was William Joseph B 1896.

Please see details of the court case regarding Webster Sylvester and William Marwick the younger. None of these documents refer to any second name.
