He was not and is not William Cyril. Cyril is not a family name. His father was William Marwick (Born 1833) had no middle name. Neither did William Marwick the younger. In his will and the will of his older brother Webster Sylvester – he is only referred to as William the younger also land title documents – copies attached. William the younger's oldest son was William Joseph B 1896.

Please see details of the court case regarding Webster Sylvester and William Marwick the younger. None of these documents refer to any second name.

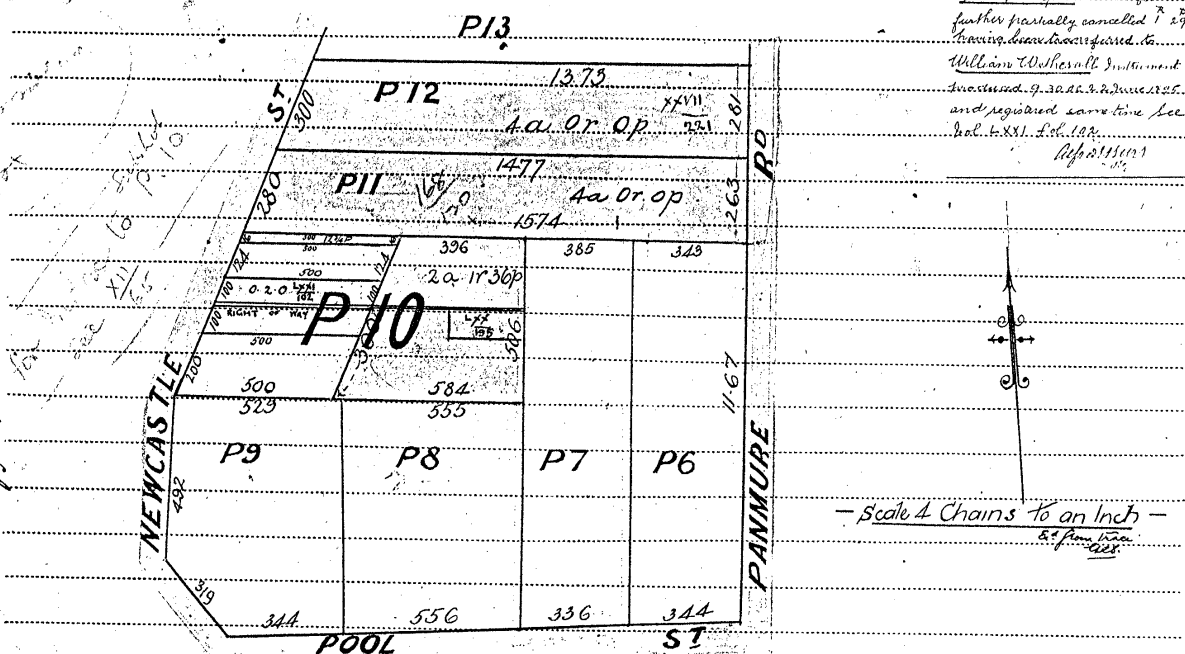

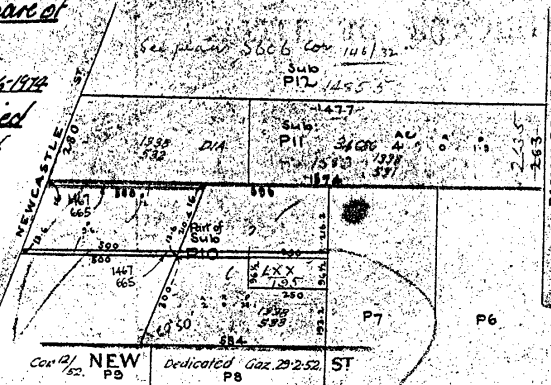

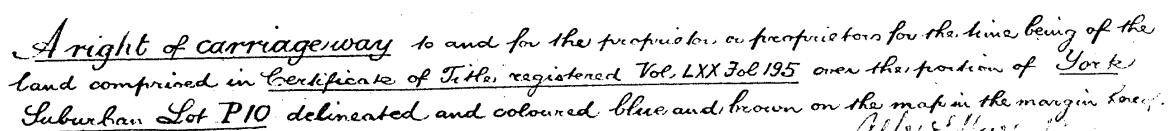
