Rachel, Alexander, Howard Douglas, Florence, Harold A. H., Margaret Lorraine, Naomi, Charles Edward. Took his bride to Victoria, returning 11.5.1880 per Otway and again 1884. ILES, Robert, arr. 1861? m. Mary MARTIN. Chd. Henry James bp. 1865, Lydia Sarah bp. 1868 d. 1869, Eliza, Alice Elizabeth bp. 1870, Ellen Matilda bp. 1872, Edith Mary b. 1874, William George b. 1875 bp. 1878. Guildford, carter & labourer. Employed 5 T/L men at Woodbridge 1866-1870.

ILES, William George, b. 31.12.1875 (Guildford), son of Robert & Mary, m. 1898 Annie Elizabeth RUSSELL, dtr. of Thomas. Chd. 4 sons & 1 dtr. Post & Telegraph operator, serving at Esperance, Coolgardie, Goldfields, Beverley (1900), Carnarvon (1905) & Mt Magnet. Manager at Carnarvon of Settlers Hotel 1911, Mayor & Member of local sporting bodies. Educ. Guildford.

ILES, William, b. 1858 (Eng), son of John & Ann (nee Hardy). INCKPEN, Mary, b. 1830 (England), arr. 6.4.1859 per Hamilla Mitchell. Housemaid.

INDARRA, Bob, m. Annie MINGONAH, of Wooginarras, she m. 2nd 22.9.1883 Alex CAMPBELL (expiree), who arr. 9.6.1862 per Norwood, he applied unsuccessfully for a land grant, a system long discontinued of giving land to spouses of Aboriginal woman.

INDOLAN, Annie, half caste dtr. of Norlup (Drolup), employed by Sgt. T. Bailey. Benjamin HARRISON requested permission to marry her in 1855, but she declined the offer, m. 1878 Thomas (William) SHEEN (SHEHAN).

INEDALL (?), William, m. Mary. Chd. George bp. 1864 (Perth C/E).

ING, Walter H. Arr. 21.6.1887 per Yeoman from London, m. Hannah PATIENCE b. 23.8.1870 (Greenough), dtr. of John & Ann (nee Criddle). Chd. Eileen b. 1896, John b. 1899, Walter Newton b. 1905.

INGERSOLE, James, b. 1821, son of James (labourer), arr. 25.6.1840 per Runnymede, m. 10.4.1850 (Perth Wesl) Emma CUFF b. 1833. Pte. 51st Regt. stationed at Rottnest, discharged 4.1847. To Geraldton & returned per Champion 26.3.1850 with L. Burges, a pioneer settler at Champion Bay. To Toodyay by 12.1850.

INGLEBY, William, b. 1832, d. 29.12.1877 (Perth), (expiree). Arr. 1.6.1858 per Lord Raglan. Teamster, employed by Thomas Wilson of York, when he died, crushed against a wall by his wagon.

INGLETON, Alexander, b. 1836, d. 3.6.1886 (Melbourne). Arr? 20.11.1873 per Centaur from Eastern colonies. Came from Hoemskirk, Tasmania, to set up in business at Geraldton, mine manager "Narra Tarra", Northampton (1875-1881 Alm). Employed 13 T/L men including miners 1874-1879. Left 11.1.1881 to establish a business in Tasmania.

INGLETON, David Cunningham, b. 1859, d. 22.9.1917 (Geraldton), (brother of Alexander), m. HEPBURN, sister of David. Chd. Hope, Bert, George Walter. Arr. per Daylight 10.8.1877 from London. Applied for 50 acres Victoria district 1880 as an immigrant grant. To and from Bunbury 1878. Was employed in Post & Telegraph Department at "Narra Tarra" (Govt. Gazette 1889). Gaoler at Geraldton for many years.

INGLETON, George, son of George (Importing Co.), m. 24.5.1875 (Perth Congr.) Alice SPENCER, dtr. of Henry & Sarah Hannah de Mayo (widow) (nee Mews). Chd. son b. 1876. Perth, merchant (1874-1880 Alm) St George's Terrace & Stirling Street. Wife & 2 chd. to Albany 27.7.1880 per Rob Roy.

INGLIS, James (or Peter), b. 1824, arr. 12.1864 en route to Camden Harbour from Melbourne. Member of abortive Camden Harbour Pastoral Assoc. He asked permission 1865 to re-select land in North West. (11,500 acres at De Grey River).

Assistant to Dr. Hope 1881. To Albany 1888 to take over practice of Dr. W. Maloney. Was surgeon by appointment to W.A. Land Co. Served in 2nd Contingent Boer War - was wounded and invalided to England. To W.A. in 1902 as Major. Health officer at Albany. Medical officer at the Forts. Educ. in Yorkshire and qualified at St Mary's.

Levi b. 1864 d. 1864. York. Employed 2 T/L men 1871 & 1874 at Salt River. A reaper, Quellington (1886-1889 Alm.). C/E.

INGRAM, W. Arr. per SS Triumph from New Zealand to Derby via Sydney and Darwin en route to Kimberley goldfields 27.7.1886. Signed a petition at Derby against quarantine of ship for a case of scarlatina.

INGRAM, William, b. 1841 (England), d. 1928 (expiree), arr. possibly 9.6.1862 per Norwood, m. 1859 Mary JOYCE b. 1839/40 (Ireland) d. 30.9.1918, dtr. of Clement & Betsy (nee Robinson). Chd. on honeymoon and returned 1.1.1880 per Tanjore. To Eastern colonies
about time of father's death and returned 25.11.1886 per Tasmania.
Member of Albany Town Council 1886.

1870 on the Toodyay Bd. of Educ. Member of Mechanics Inst. & Reading

INSKIP, G. A. Passenger from Frem. to KGS 7.1884. Visited Eastern colonies & returned 2.1885 per Ballarat and 13.9.1886 per Sutlej. Perth, architect (1886/87 Alm).

INSKIP, Sgt. Major Henry J. of 94th Regt, arr. possibly per Sea Park 6.4.1854 with wife & 2 chd. Eliza b. 1844 d. 1855, Ellen b. 1853 d. 1855 of fever. Dep. for SA with family 1.11.1855 per Vivid. Enrolled Pensioner Guard.

INSLEY, C. Employed a T/L man at Busselton 1867.

IRBY, A.H. Arr. 25.6.1840 per Runnymede. Lt. in the 51st Regt. He sought his discharge from the Army in 7.1847, possibly in anticipation of joining T.W. Hazelwood in his pastoral venture at Bindoon, to whom he became heavily indebted. He left in 5.1850 to rejoin his company.

IRELAND, Richard, b. 1820, d. 24.9.1888, arr. 27.5.1863 per Clyde as an Enrolled Pensioner Guard. Formerly a Corporal in 63rd Regt. Perth. Howick St. Town Lot H.27 granted 1884.

IRELAND, Robert, arr. 27.5.1863 per Clyde as an Enrolled Pensioner Guard. To S.A. with wife & family (6) per Sea Ripple 9.10.1864. Formerly a Pte. D Batty. Royal Artillery.

IRELAND, T. Walter. Signwriter. Petitioner for steamship service to Wyndham 8.1886.

IRELAND, William S. (alias John Scott), b. 1841, d. 1888, (expiree). Arr. 4.7.1866 per Belgravia. Employed a T/L man 1875 at Perth. To Kimberley at time of gold rush. Murdered by Aborigines.

IRVINE, J. Cossack, pearler (1885 Alm). Dep. from Cossack for Singapore 19.5.1886 per Natal.

IRVINE, James. Chd. Pearl Ruth b. 1893, Jessie Elizabeth b. 1895 (both bp. Frem. Presb.). Fremantle 1893 & 1895. Presb.

IRVINE, John, m. Minnie. Chd. Marian b. 1896 (Frem.).

IRVINE, M.B. Arr. 28.2.1852 per West Australian. Frem. 1853-5 Clerk in Commissariat Dept. Convict Est.

IRVINE, William, b. 1833, (expiree). Arr. 29.5.1863 per Clyde. Dep. 9.3.1877 for Victoria.

IRVINE, William, b. 1856. Arr. per Charlotte Padbury 29.9.1875 from London.

IRVING, David. Arr. per Helena Mena 24.9.1886 from London.

IRVING, Frederick S, arr. 1830. Was at Toodyay working for Yule (1837 Census).

IRVING, William H. Bootmaker, Perth & Fremantle 1886.

IRWIN, Lt. Arr. 21.1.1862 per Lincelles, dep. same ship 27.4.1862.

IRWIN, Frederick Chidley, b. 1788, d. 1860 (England), son of (Rev) James, arr. 8.6.1829 per Sulphur as Captain of 63rd Regt. m. 12.1836 (England) Elizabeth COURTHOPE d. 14.5.1882 (England). Chd. Frederick Courthope b. 1838 (at sea), James C b. 1839 (Swan), John L b. 1841, Sydney b. 1843 d. 1847, Emma b. 1844, Andrew b. 1846, Sydney b. 1848, Elizabeth Mary b. 1849, Harriet Frances b. 1851, Margaret Ellen b. 1853, Emily Agnes. He was granted 3240 acres "Henley Pk" in Swan district in partnership with W.H. Mackie. The estate was managed by R. Edwards. He served in Legis. Council 1831. He was Acting Lt. Gov. 1832-1833. Then he left with the Regt. He returned to WA in 1838 as commandant & (promoted later to Lt. Col) was Acting Gov. again 2.1847-8.1848. Author of "State & Position of Western Australia". Employed a T/L man 1851. Retired 1852. He laid the foundation stone of Masonic Temple 1853. His elder chd. were sent to Eng. for educ. 16.2.1852 per John Panter. IRWIN, Samuel Thomas, m. Margaret. Chd. Sarah Ann b. 1867, Elizabeth (both bp. Perth C/E), m. 2nd 1869 Henrietta MELVILLE, widow of Robert & dtr. of William Hardman. Perth, labourer 1873. Employed a T/L baker 1876. C/E.

IRWIN, W. b. Scotland, arr. 26.8.1837 per Hero with wife. Agriculturist on Major Nairne's farm York-Toodyay (1837 Census).

IRWIN, W. Made several voyages to WA as a religious instructor on Convict Ships, arr. 13.2.1861 per Palmerston, arr. 15.4.1864 per Clara & expected to be ordained on arr. at Fremantle, arr. 15.8.1865 per Racehorse, arr. 4.7.1866 per Belgravia - 5th voyage to WA, arr. 13.7.1867 per Norwood. ?Same man arr. 29.9.1875 per Charlotte Padbury.

IRWIN, W. Arr. 29.9.1875 per Charlotte Padbury.

IRWIN, William, b. 1826 (England), arr. 13.3.1855 per Berkshire. Mason.

ISAACS, John, b. 1872, son of Samuel & Lucy Major (nee Lowe), m. 1897 Rose HARRIS. Chd. 7.

ISAACS, Lucy Mona, dtr. of Samuel, m. 1896 Peter William Stewart INNES.

ISAACS, Richard, b. 1799, arr. 6.5.1830 per Britannia with sisters Mary b. 1802 d. 26.2.1832, & Amy b. 1804 d. 10.1835. Selected 1106 acres in Avon district. Employed by J. Austin as shepherd & sharefarmed on Carey's grant 1836. Intended leaving WA 1839.

ISAACS, Samuel. Absconded from an American whaler in South West early 1830s. Employed in Augusta region. Son Samuel b. c.1845 of an Aboriginal mother.

ISAACS, Samuel, b. 1845, d. 14.7.1920, son of Samuel & Aboriginal mother, m. 8.1.1870 Lucy Major LOWE, dtr. of James Major & Mattie. Chd. John b. 1872, Lucy Mona b. 1875 d. 1899, James Herbert b. 1877, Samuel Andrew b. 1879, Frederick Augusta b. 1882 d. 1956, Henry b. 1883. Isaacs reared by Dawson family at Westbrook. Worked for Alfred Bussell as stockman. Assisted Grace Bussell 12.1876 to rescue survivors of Georgette. Awarded Bronze Medal & a grant of 100 ac. near Wallcliffe, which he established as his farm & home "Ferndale". In 1890s worked for Gale at Vasse, Bullocky, at Karridale & Boranup Timber Mills. Illit. C/E.

ISACSON, John, b. 1807, arr. 6.10.1829 per Lotus. Compositor & printer by trade. He was granted 200 acres in 1830.

ISBESTER, S., d. 4.3.1878 (drowned). Shipwright, Cossack pearler - owner of lugger The Chip lost in cyclone.

ISDELL, James, b. c.1849, d. 5.10.1919 (Perth). Arr. 21.11.1883 per Franklin from Eastern colonies and again 10.4.1884 per Star Queen. Mrs sailed from Frem. to KGS 4.3.1884 per Franklin. North West, farmer, grazier & pearler. Broome 1886 - had half interest in Schooner Willie. Joined Kimberley gold rush. 1887 Pilbara & Marble Bar. JP at Nullagine 1902. Travelling protector of Aborigines 1906-9 in Marble Bar and Kimberley districts and at Turkey Creek 1910-1915. Storekeeper at Pilbara 1916.

ISHMAN, J. Arr. 18.11.1876 per Emily from Melbourne.

ISKE, A. Dep. 5.12.1887 per South Australian for S.A.

ISLAND, John, b. 1822, d. 5.9.1860, arr. 18.10.1851 per Minden as an Enrolled Pensioner Guard. Formerly a Pte. 2nd Regt. & a file-maker by trade.

ISLES, Miss. (see ILES)
Guildford, dressmaker (1883 Alm).

ISLIP, arr. 25.5.1856 per Prince Charlie from London & Cape of Good Hope with wife.

ISOM, Joseph, b. 1823, (expiree). Arr. 18.10.1851 per Minden. Employed 7 T/L men 1851-1878.

ISRAEL, Brina, b. 1833, arr. 13.1.1853 per Travancore. Associated with Theodore Krakouer in livery stable business 1850s.

ISRAEL, Esther, b. 1836, arr. 13.1.1853 per Travancore, associated with Elias Lapidus in livery stable business, m. 12.1.1860 (Frem) James SARGENT.

ISRAEL, (Lt.) Seigmund, b. 1840 (Germany). Arr. in Victoria 1886/7 and to W.A. 29.6.1888 per Albany with A. Carlson. He was a military officer and explorer in West Africa and Congo. Appointed by German Government to take part in expedition annexing German West Africa. In 1888 represented a Melbourne syndicate and prepared to prospect and explore in Yilgarn with A. Carlson, Hampson and Sayers. Educ. at German Military and Naval Schools.

ISSOTT, Joseph, b. 1819, (expiree). Arr. 13.4.1864 per Clara. Widower on arrival. Sawyer, hawker etc. Canning, storekeeper (1884-9 Alm).

ISTEAD, Henry, b. 1861. Arr. per Oriana 16.7.1886 from London. Farm labourer.

ITALIAN, John. Perth, porter (1884-5 Alm).

IVERMY, Katherine Anne, b. 1829, d. 1912, m. John DIXON b. 1831 d. 1903.

Edward Patrick b. 1856, Richard b. 1857, Frederick George b. 1860 (Frem RC), John buried 1861 at 1 day old, Maria b. 1861 d. 1862 (Frem), Henrietta b. 1861, Mary Ann b. 1863 (Frem RC), Eliza b. 1865 (Frem RC). York 1850s. Fremantle 1862. Baker. Employed 10 T/L men 1863-1866 including 3 bakers & a shopman. Lit. C/E, 1860 conv. RC. Wife RC.

IVES, Samuel, b. 1802 (England), arr. 5.3.1831 per Eliza. Agricultural labourer in Canning district (1837 Census). He was at Upper Swan in 1841.

IVEY, Thomas, b. 1839, arr. 26.7.1863 per Hastings. Engineer at Wheal Fortune Mine, Northampton. In 1863 nominated brother Henry b. 1841 (unm) of Penzance Cornwall as a migrant.

IVIS, Catherine, m. Edwin BIGGERS.

IZZARD, William, b. 1810, d. 8.5.1886, arr. 3.2.1830 per Hooghly.
Brickmaker & bricklayer, Perth. Submitted a tender to build the toll
gate of Perth jetty which was accepted (12.1847 Inquirer). Admitted to
hospital (aged 32) 12.1840. Billiard marker 1879-1886. Admitted to Mt.
Eliza Invalid Depot 23.1.1886. Employed a T/L bootmaker 1852.

IZZARD, William, b. c.1785, d. 1.8.1865 (Perth), arr. 1.1.1834 per
Australia from N.S.W. Arr. 15.9.1834 per Mary from Cape. Barber 1844,
Perth. labourer.
